The fund's Standard Deviation reached 16.26% compared to 19.84% at the Annual return - 2015. which indicates a decrease in the risk level.

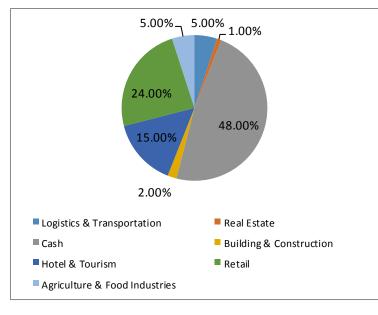

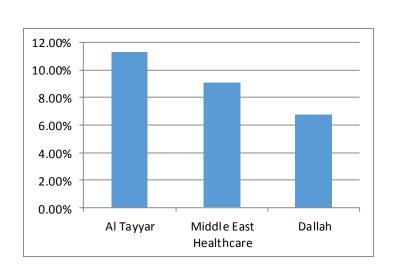

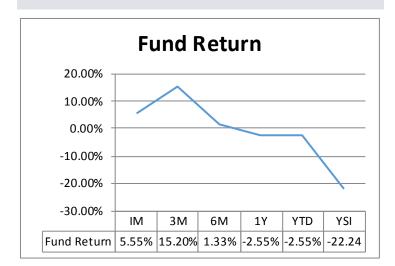

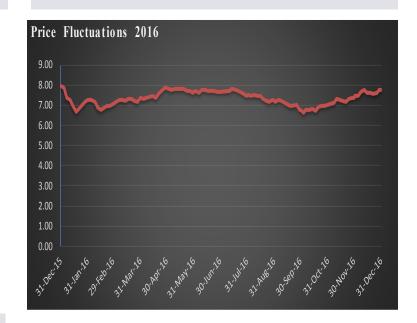
