The company's headquarters is located in Riyadh. Sahara is one of the Saudi companies registered in the Saudi financial market "Tadawul". The company works as a holding company that focuses its main activity on the petrochemical sector in KSA. In the performance of its business, Sahara Petrochemicals is committed to implementing high quality standards of production, with a great responsibility to preserve the environment, to ensure the safety of its employees and to contribute to the good of society in general.

Providing promising work opportunities for its employees with a focus on applying the Saudization program in all departments of the Company.

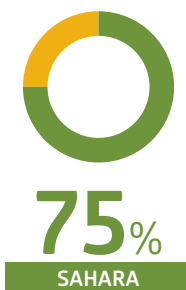

## AL WAHA Petrochemicals Company (AL WAHA)



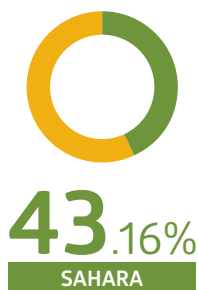
AL WAHA, a joint venture between Sahara and Basell Arabie Investissements, was incorporated in September 2006 with the objective of owning and operating a petrochemicals complex. The company, located in Jubail Industrial City, produces Propylene as primary feedstock for the production of Polypropylene.

## Sahara & Ma'aden Petrochemicals Company (SAMAPCO)



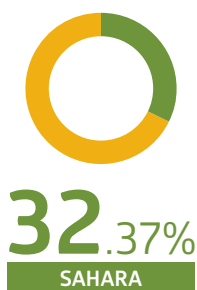
SAMAPCO, a 50:50 joint venture between Sahara and Ma'aden, was incorporated in August 2011 to construct, own and operate an integrated chlor-alkali plant as well as an ethylene dichloride plant, together with the associated utilities and support facilities in Jubail Industrial City.

## Saudi Acrylic Acid Company (SAAC)



SAAC was incorporated in April 2009 as a limited liability company in which Sahara owns 22%, TSOC owns 65% and Tasnee owns the remaining 13% of the share capital. It is a holding company for investments in other joint venture projects including the Integrated Acrylates Complex project.

## Saudi Acrylic Polymer Company (SAPCO)



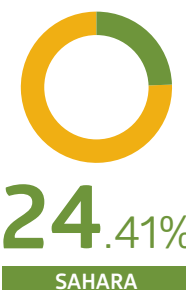
SAPCO was incorporated in April 2012 as a mixed limited liability company between SAAC and Evonik, in which Sahara owns an indirect equity stake of 32.37%. The company owns and operates the Super Absorbent Polymer plant of the Integrated Acrylates Complex.

## Tasnee & Sahara Olefins Company (TSOC)



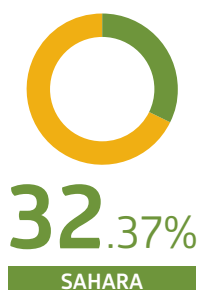
TSOC was incorporated in May 2006 as a closed joint stock company in which Sahara owns 32.55%. Its current holdings comprise a 75% equity stake in Saudi Ethylene & Polyethylene Company and a 65% equity stake in Saudi Acrylic Acid Company Limited.

## Saudi Ethylene & Polyethylene Company (SEPC)



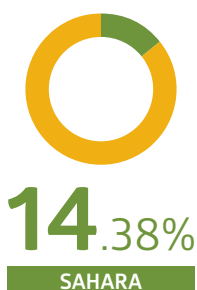
SEPC was incorporated in May 2006 as a limited liability company between TSOC and Basell Moyen Orient Investissements. Sahara owns an indirect equity stake of 24.41% in SEPC. The company owns and operates a petrochemical complex for the production of Propylene and Ethylene.

## Saudi Acrylic Monomer Company Limited (SAMCO)



SAMCO was incorporated in July 2009 as a mixed limited liability company between SAAC and Dow Chemical. Sahara owns an indirect equity stake of 32.37% in SAMCO. The company owns and operates the Acrylic Acid and esters plant of the Integrated Acrylates Complex.

## Saudi Butanol Company (SABUCO)



SABUCO, incorporated in May 2013, is a mixed limited liability company between SAAC, Saudi Kayan Co. and Sadara Chemicals Co. Sahara owns an indirect equity stake of 14.38% in the company. SABUCO owns and operates the n-Butanol plant of the Integrated Acrylates Complex.

## Sahara Marketing Company



Sahara Marketing Company, a subsidiary of Sahara Petrochemicals, was incorporated in December 2016. The company's activities include wholesale of industrial chemicals and petrochemicals and marketing services for other companies, which is part of Sahara's strategy to take advantage of the growth of petrochemical products to expand its business in every aspect.
