# Arabian Cement

## Q4: Earnings in line; TP revised to SAR25/sh

Arabian Cement reported in-line Q4 earnings at SAR16mn, supported by higher other income, offsetting weak gross margin. Top-line grew +48% q-o-q (-29% y-o-y), above our and consensus estimates, largely driven by better-than-expected realized prices, both domestically and at Jordanian subsidiary as well. So far in Q4 earnings, we have observed a sharp increase in realized prices for most of cement producers including Arabian Cement, reflecting their shift towards higher pricing strategy. Accordingly, we revise our cement sales price forecast for the future periods and a marginal pick in sales volume. Further, we expect a continuous recovery in the Jordanian operations. Moreover, the company has a healthy cash position, valuable liquid assets and on-market average dividend distribution (2019E yield: ~5%). Therefore, we revise our TP to SAR25/sh. as well rating to Neutral on the stock.

**Q4 results:** Q4 revenue reported at SAR175mn (-29.3% y-o-y; +48.7% q-o-q), above our (SAR146mn) and consensus (SAR163mn) estimates, led by higher realized cement prices (SAR165/ton in Q4 vs. SAR127/ton in Q3) along with better selling price at the Jordanian subsidiary. However, gross margins narrowed to 10.3% in Q4 (36.2% in Q3), significantly below our expectation, on higher-than-expected rise in production costs (+20% rise as per our calculations), however, we expect production costs to return to normal levels in the future. The company might have generated around SAR20-25mn non-operating income, which has largely offset the impact at the net profit level. Consequently, net profit came in at SAR16mn, broadly in line with our estimate of SAR17mn (consensus: SAR4.5mn).

**Valuation and Conclusion:** Arabian Cement, as of Jan 2019, has 2.5mn tons of inventory, which constitutes ~97% of its TTM sales. Post Q4 results, we revise our forward looking estimates upwards, on account of improvement in average cement prices and a slight recovery in sales volumes. Further, Arabian Cement has distributed a dividend of SAR 1/sh in 2018. We believe that the company is likely to increase the payout further in 2019, owing to healthy cash position, high retained earnings level and highly valuable liquid assets. Further, the company trades at an attractive dividend yield of ~5.0%, which is positive for income-seeking investors. Accordingly, we raise our target price to SAR25/sh (SAR20.5/sh earlier) and the rating to Neutral (Underweight earlier) on the stock.
