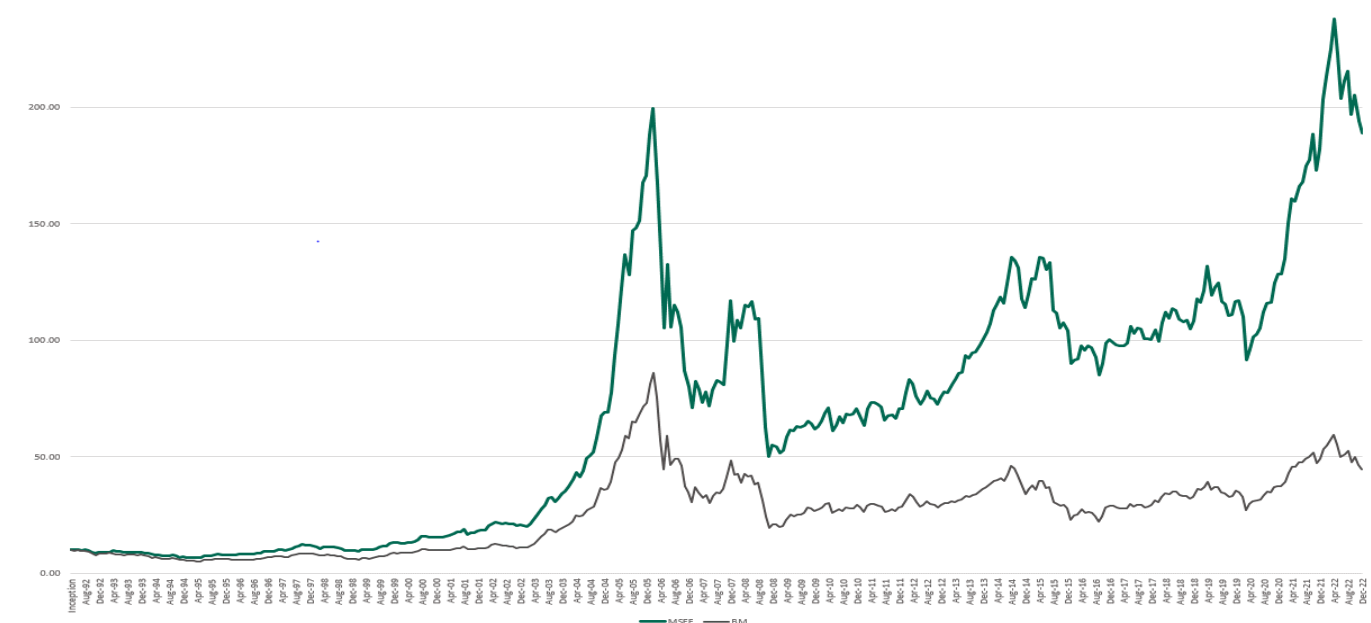

### Manager Performance

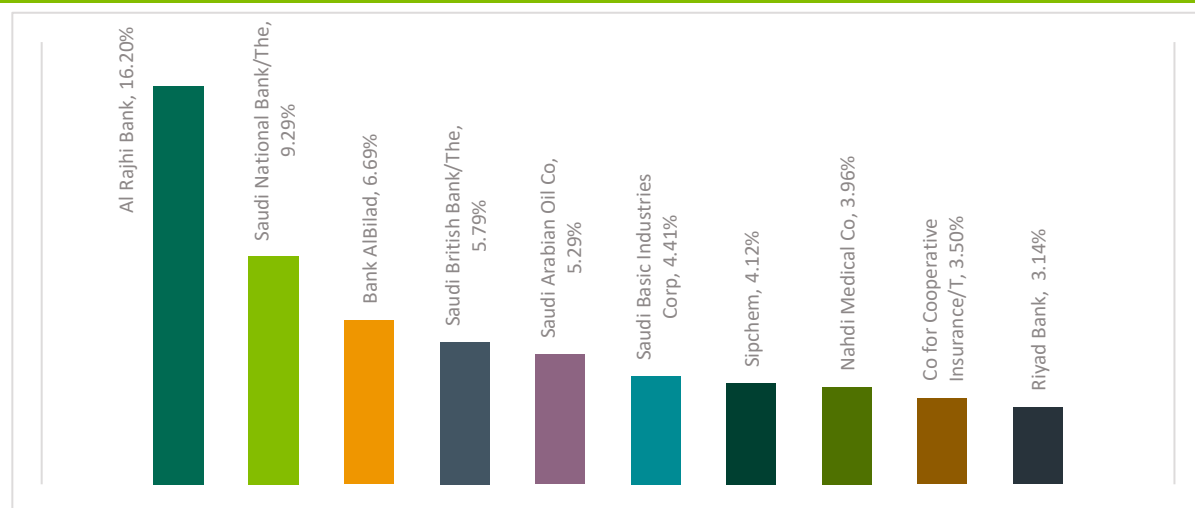
May 1992 - December 2022 (Single Computation)



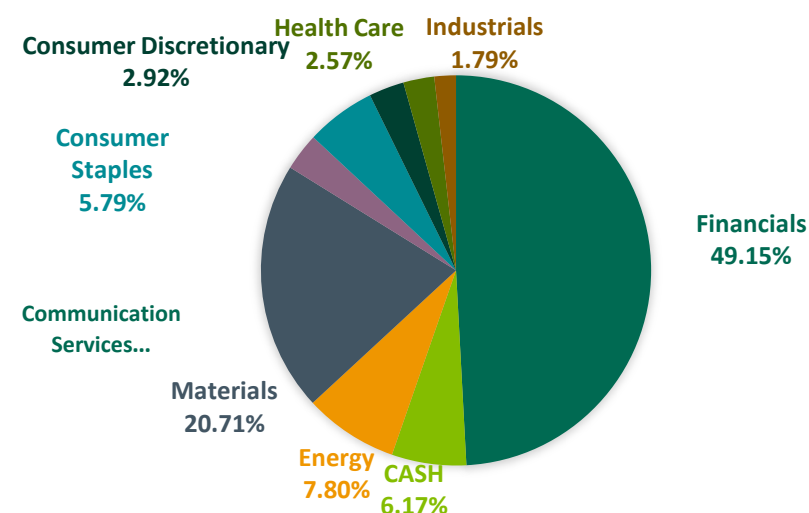
