


Group Key Financial Indicators Q3 2023 vs Q3 2022 (SR K)





Group Key Financial Indicators YTD 2023 vs YTD 2022 (SR K)



Revenue Movement Per Sector YTD 2023 vs YTD 2022(SR K)

















Cash Flow Performance 30-09-2023 vs 31-12-2022 (SR K)
