## Performance Review

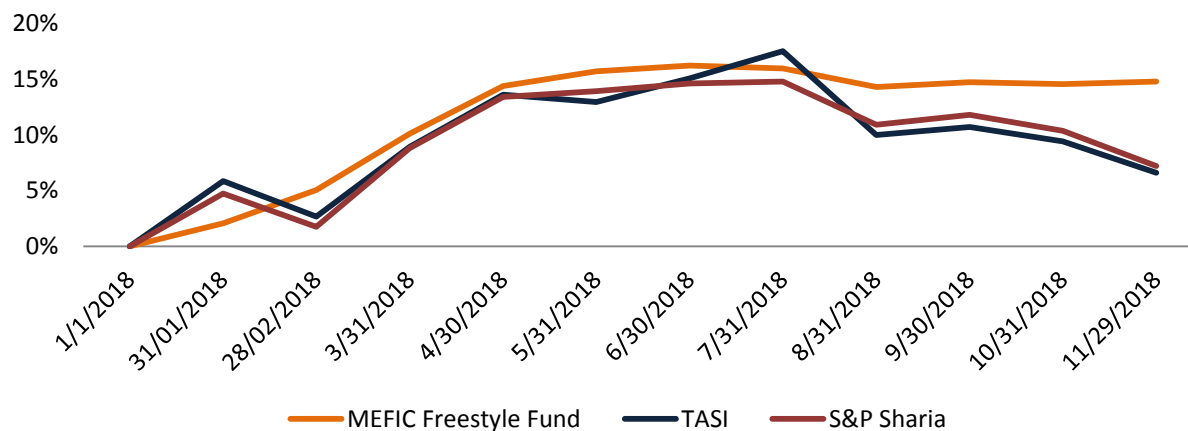
The Saudi Stock Market Index (TASI) achieved positive returns to close by the end of the month at 7,702.99. The total value of shares traded for the month reached SAR 62.18 billion, increasing by 35.05% over the previous month. The main sectors that achieved a positive performance were Retailing (3.32%) and Insurance (2.79%). On the other hand, Food and Beverages and Pharma, Biotech & Life Science declined by (-5.36%) and (-5.32%), respectively.
