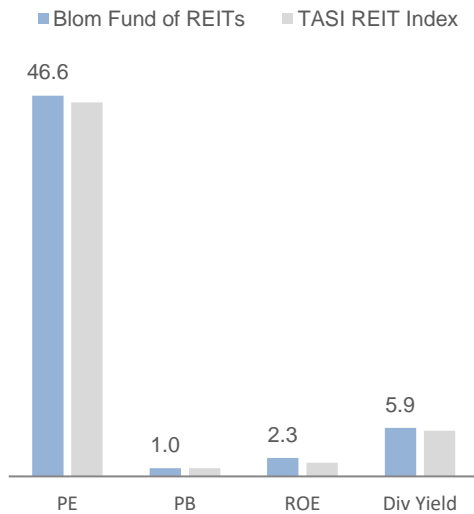
INVESTMENT OVERVIEW

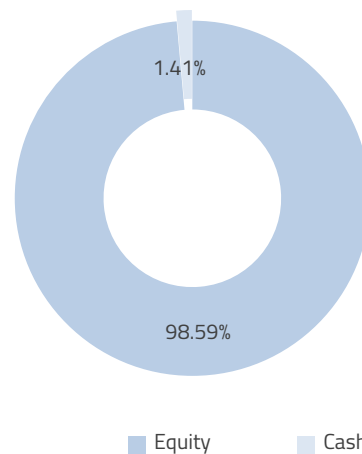
