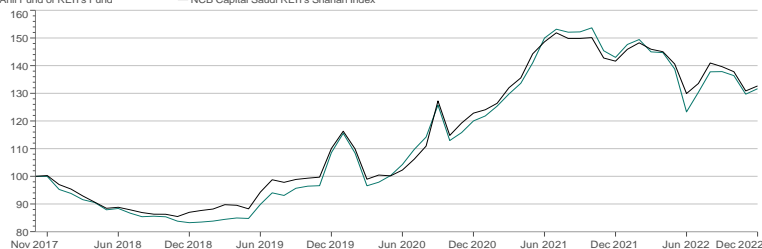

December 2017 - December 2022 (Single Computation)

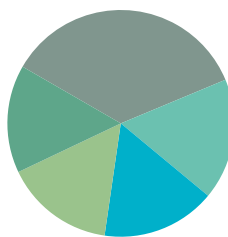

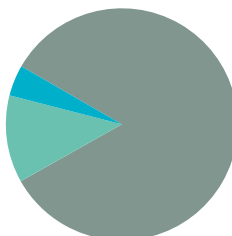
