

SAUDI KAYAN Third Quarter 2023 Earnings

Third Quarter 2023 Highlights:

- Revenue of SAR 2,137.26 million [\$ 569.94 million], a 3% decrease quarter-over-quarter and a 18% decrease compare to the same quarter last year.
- EBITDA of SAR 362.42 Million [\$ 96.65 million], a 3% decrease quarter-over-quarter and a 612% increase compare to the same quarter last year.
- Loss from operations of SAR 265.97 million [\$ 70.92 million] a 11% decrease quarter-over-quarter and a 61% decrease compare to the same quarter last year.
- Net Loss of SAR 448.97 Million [\$ 119.73 million], a 14% decrease quarter-over-quarter and a 45% decrease compare to the same quarter last year.

Financial Performance:

- SAUDI KAYAN Petrochemical Company (SAUDI KAYAN) today announced its financial results for the third quarter of 2023. The company's revenue reached SAR 2,137.26 million [\$ 569.94 million], a 3% decrease quarter-over-quarter due to decrease in the average sale prices and a 18% decrease compare to the same quarter last year due to decrease in sales volumes and decrease in the average sale prices.
- The average sale prices in the third quarter of 2023 decreased by 10% quarter-over-quarter and a decreased of 13% compare to the same quarter last year. Sale volumes increased by 7% quarter-over-quarter and a 5% decreased compare to the same quarter last year.
- EBITDA amounted to SAR 362.42 million [\$ 96.65 million] in the third quarter of 2023, representing a decrease of 3%, quarter-over-quarter. This was primarily to decrease in the average selling prices.
- Net loss in the third quarter of 2023 was SAR 448.97 million [\$ 119.73 million], or SAR -0.26 per share [\$ -0.07 per share] compare to a net loss of SAR 392.13 million [\$ 104.57 million], or SAR -0.26 per share [\$ -0.07 per share] achieved during the second quarter 2023.
