

Price Stabilizing and Liquidity Providing Agreement between Silah Gulf B.S.C. and SICO B.S.C. (c)

End of Price Stabilizing Period and Commencement of Liquidity Providing Activities

Reference is made to our earlier announcement dated 9th February 2026 in relation to the Price Stabilizing and Liquidity Providing Agreement (the "**Agreement**") entered into between Silah Gulf B.S.C. (the "**Company**") and SICO B.S.C. (c) ("**SICO**") in connection to the Company's initial public offering.

The Company would like to announce that the price stabilizing period ended on 11th March 2026, being the 30th day from the commencement of trading on 10th February 2026.

In addition, the Company would like to announce that the Liquidity Providing activities shall come into effect 12th March 2026 and continue for a minimum period of 5 (five) months pursuant to the abovementioned Agreement.

The maximum number of shares that SICO may own at any given time on behalf and for the account of the Company under the Agreement shall be equal to 3% of the Company's issued share capital.
