The fund aims to achieve an absolute return of capital growth over the long term, by investing mainly in the initial proposals in the Saudi stock market, as well as in shares of newly listed companies in Saudi Arabia and the GCC stock market during the first three years of listing.

The Fund that invests in the Saudi capital market in Saudi Arabia, has achieved Average Return during the Q3 - 2017 of -0.89%


The fund's Standard Deviation increased to 10.61% compared to 4.26% at the Q2 - 2017 Which indicates an increase of the risk level.


Performance
