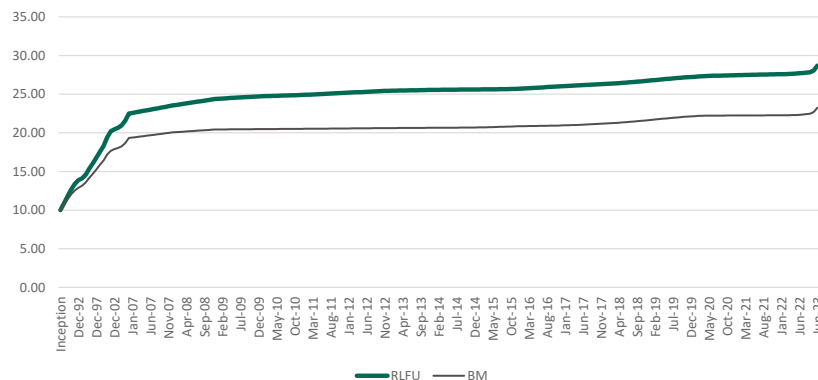

## Manager Performance

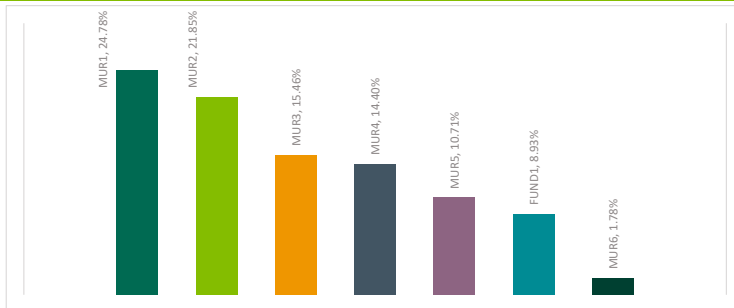
September 1987 - June 2023 (Single Computation)
