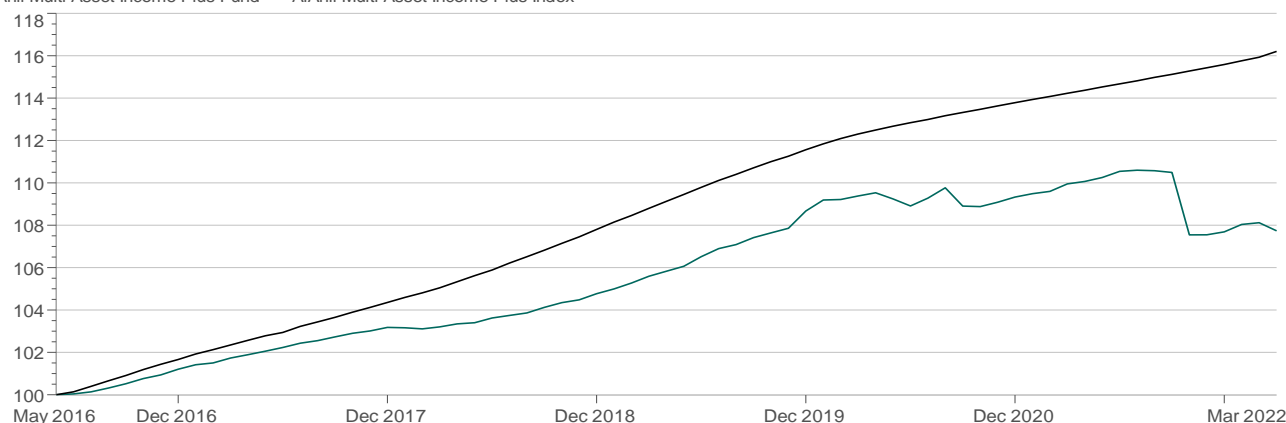

June 2016 - March 2022 (Single Computation)

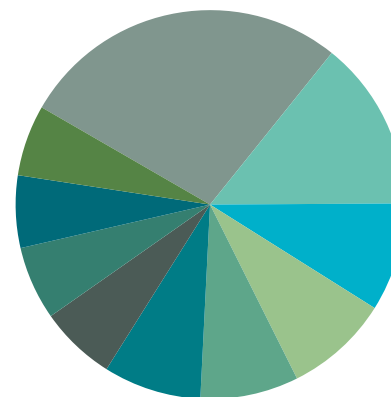
— AlAhli Multi Asset Income Plus Fund — AlAhli Multi Asset Income Plus Index

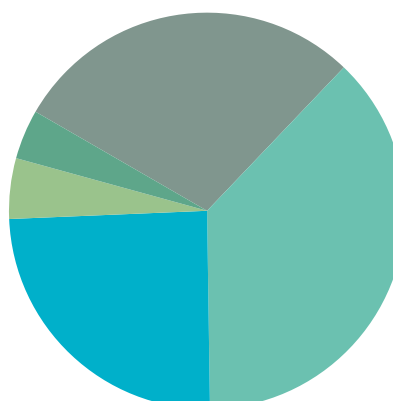
